Diminished mental capacity is an issue with wide-ranging implications for the life of a person and her or his loved ones. This bilingual expert panel will discuss the importance of adopting a multidisciplinary approach to mental capacity. Current responses and challenges with regard to diminished mental capacity will be described from the perspective of medical researchers and clinicians, social workers, government agencies, pro bono legal actors, legal researchers and the judiciary. Panelists will also discuss how differing professional approaches could be coordinated to centre around the key values of presumption of capacity, promotion of autonomy, maximization of positive family and social connections, and support for residual capacity. The panel will emphasize the particular vulnerability of persons with diminished capacity within the medical and legal systems, and the need for increased comprehensiveness, sensitivity and collaboration among professionals in these areas. This collaborative approach would allow for determinations of capacity and protections which minimally restrict autonomy.

The panel event will be followed by a reception. All are welcome.

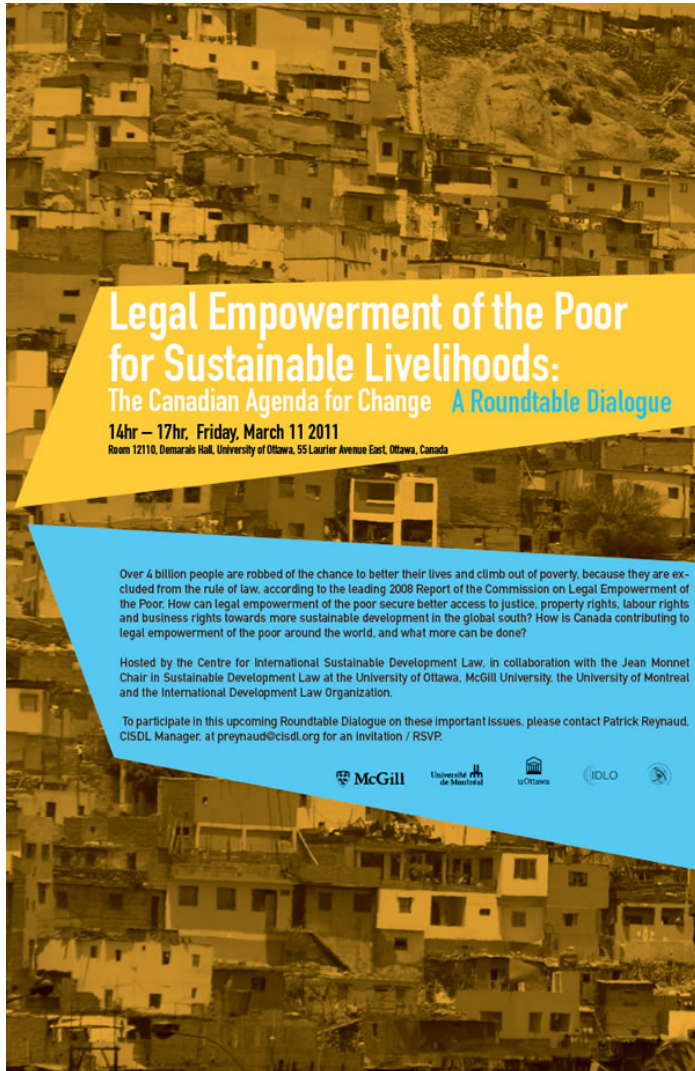
